<b>Strand: E1 Reading</b> Reading is a process that includes demonstrating comprehension and showing evidence of a warranted and responsible interpretation of the text. "Comprehension" means getting the gist of a text. It is most frequently illustrated by demonstrating an understanding of the text as a whole; identifying complexities presented in the structure of the text and extracting salient information from the text. In providing evidence of a responsible interpretation, students may make connections between parts of a text, among several texts, and between texts and other experiences; make extensions and applications of a text; and examine texts critically and evaluatively.	
<b>E1a:</b> The student reads at least twenty–five books or book equivalents each year. The quality and complexity of materials to be read is based on the lexile level for grade twelve (1100L–1349L). The materials should include traditional and contemporary literature (both fiction and non–fiction) as well as magazines, newspapers, textbooks, and on–line materials. Such reading should represent a diverse collection of material from at least three different literary forms and from at least five different writers.
